TERMS & CONDITIONS

- 1. Access to sites will be available from THURSDAY MARCH 6TH 2025.
- **2.** Stall holders are responsible for their own stall safety including implementing risk migration strategies for work health and safety.
- **3.** Ground Space applicants agree to supply a copy of their Public Liability Insurance Certificate of Currency noting a minimum of \$20 Million cover & COVID-19 Safety plan specific to your site/activity if applicable.
- **4.** Hobbyist Stallholders can come under the Cooma P & A Show Society's Insurance cover but must read and sign the "Hobbyist Stallholders Only" declaration section provided. This comes with a small administration fee of \$15.
- **5.** Food Vendors must supply a copy of their Food Safety Supervisor Certificate. All food vendors must have a tested and tagged (within last 12 months) fire extinguisher.
- **6.** All leads and electrical equipment must be tested, tagged and in date for safety reasons. Any lead not tagged will be removed from site (limited power sites available).
- **7.** Each site holder will be entitled to 2 entry passes. Prior to the show weekend (depending on size of site and cost) limited additional entry passes at a cost of \$5 per person.
- **8. NO** refunds after Saturday 8th March 2025.
- **9.** Any sites not occupied by 8am Saturday 8th March 2025, will be reallocated.
